1. INTRODUCTION

引言

- 1.1. FXTM¹ is running the 2023 INTEREST FOR BALANCE PROMOTION (the “**Promotion**”) which is applicable to selected clients at FXTM’s discretion, excluding clients assigned under IB & Affiliates. By participating in this Promotion, you agree to be bound by the Terms and Conditions herein (hereinafter referred to as the “**Terms**”) as these are set out below.

本2023年账户结余利息收入优惠活动（以下简称“**活动**”）适用于由FXTM富拓决定的特选客户（代理商及网络联盟商名下的客户不适用）。参加本次活动即表示您同意受以下条款和条件的约束（以下简称“**条款**”）。

- 1.2. All Times stated in these **Terms** are provided in EET (Eastern European Time) – Server Time in MT4.

*此条款中所提到的所有时间均为欧洲东部时间（EET） - MT4服务器时间

- 1.3. This Promotion Period shall run from the 1st of September 2023 (00:01) (the “Launch Date”) until FXTM decides to suspend or terminate it (the “Promotion Period”).

- 1.4. The Promotion is applicable to all account types (Micro, Advantage and Advantage Plus).

本活动适用于所有账户类型（微型账户，超低点差账户及0佣金账户）。

- 1.5. A client who participates in this Promotion shall receive the “**Interest**” as defined in accordance with clause 4 of this Promotion and subject to the Terms herein.

2. INTERPRETATION OF TERMS

- 2.1. “**Selected Clients**” shall mean a Client whose registered email receives the official promotion invitation sent by FXTM Official Email Account (no-reply@news.fxtmmail.com), forwarded email is not eligible, during the **Promotion Period**

“特选客户”指活动期间，在注册邮箱中收到 FXTM 富拓官方邮箱（FXTM <no-reply@news.fxtmmail.com>）发送的活动推广邮件的 FXTM 富拓客户。此活动仅对收到 FXTM 富拓发送的官方活动推广邮件的客户开放，转发及其它任何渠道及形式的邮件均不适用。

2.2. “**Total Cash Balance**” shall mean the sum of all Cash Balance (excluding the unrealized P&L, trading credits and used margin) of the eligible clients’ all trading accounts and FXTM wallets.

2.3. “**Daily Total Cash Balance**” shall mean at 23:59 that day, the sum of all Cash Balance (excluding the unrealized P&L) of the eligible clients’ all trading accounts and FXTM wallets

2.4. “**Daily Average Cash Balance of the Month**” shall mean the sum of the clients **Daily Total Cash Balance** in that month/days of that month.

2.5. Please note that all **Total Cash Balance** mentioned in these T&C is calculated in USD, if the clients Daily Total Cash Balance is in other currencies, it shall be converted to USD according to FXTM Conversion Rates on that day. Click [here](#) to check the FXTM Conversion Rates.

2.6. Please note that all hours mentioned in these T&C are in **EET (Eastern European Time) – Server Time in MT4**

3. ELIGIBILITY CRITERIA

资格标准

3.1. To participate in this Promotion, you must meet the following requirements:

为参加本次活动，您须满足以下条件：

- a) You are an existing client of FXTM with FXTM live trading accounts, or a dormant client of FXTM, eligible to trade in accordance with, and have agreed to, the operative agreements;

您是拥有富拓真实交易账户的富拓现有客户，或是有资格根据有效协议进行交易的FXTM的不活跃客户；

- b) Read and accept the Terms of this Promotion;

3.2 The Promotion shall only be available to each client at the discretion of FXTM to offer the **Interest** and shall be given to the client after receipt of the client's Acceptance of these Terms.

本活动由FXTM富拓自行决定在客户接受本条款后给予“利息”。

3.3 If the client wishes to join this Promotion, the client must reply “Opt-in” in FXTM Official WeChat Account or click on the “Opt-in” button in the Official Invitation Email sent from FXTM Official Email Account (FXTM <no-reply@news.fxtmmail.com>), forwarded email is not eligible.

若客户想加入此活动，客户需在微信回复相关报名关键词或按下FXTM富拓官方邮箱（ FXTM <no-reply@news.fxtmmail.com> ）发送的活动推广邮件中的“退出活动”按钮，转发及其它任何渠道及形式的邮件均不适用。

4. SPECIFIC PROMOTION TERMS

特别活动条款

4.1. Eligibility Requirements

活动资格要求

4.1.1. Eligibility

合资格要求

- a. To be eligible for receiving the Monthly Interest, if you are a new client of FXTM, you must have opened a MyFXTM account with FXTM for the first time before 00:01 on the first day of the month.

If you first opened your MyFXTM Account after the first day of the month 00:01, then you

will not be eligible to receive the interest of this month, and you can only join the FXTM interest promotion of the following month.

为享受当月利率，若您是富拓的新客户，您首次开设FXTM富拓MyFXTM账户的时间必须早于当月第一天的00:01。

若您首次开设FXTM富拓MyFXTM账户的时间晚于当月第一天的00:01，则您无法享受当月利率，您只可于下月开始参与FXTM的账户结余利息收入优惠活动。

4.1.2. Trading Requirements

交易要求

- a. To be eligible for receiving the Monthly Interest, the Selected client cannot have any withdrawals during the entire month (1st day of the month 00:01 – last day of the month 23:59) (inclusive) in which the clients wish to be eligible for the monthly interest rate.

Once the client has any withdrawals, the client's eligibility for that monthly interest will be automatically forfeited.

为享受当月利率，特选客户在当月（当月的第一天0点01分至当月最后一天23点59分）（含以上两个时间点）期间不可以有任何出金行为。

一旦客户进行任何出金，该客户当月的利率资格将会自动作废。

- b. To be eligible to enjoy the monthly interest, the Selected Client must complete a minimum trading volume of 10 lots during the entire month (1st day of the month 00:01 – last day of the month 23:59) (inclusive). One trade refers to a complete round trip of opening and closing a position. Only positions opened and closed for more than 5 minutes are considered eligible. Long and short positions at the same time are not counted as eligible.

为享受当月利率，特选客户在当月（当月的第一日0点01分-当月的最后一日23点59分）（含以上两个时间点）期间需完成10手的最低交易量要求。一手合资格交易指开仓、平仓一个来回的完整交易。只有开仓和平仓且开仓时间超过5分钟的交易才会被计入交易手数。同时做多做空不会被计入交易手数。

4.2. Interest Rate

4.3. The amount of Interest the Eligible Clients are entitled is calculated based on the client's average daily Total Cash Balance in that month as stated in the table below:

4.4. Interest Delivery

FXTM will review eligible clients at 00:01 of the 1st day of the month, FXTM will deliver the monthly interest to eligible clients' FXTM USD wallet within the first 5 working days of the following month.

FXTM富拓将于每月第一天的00:01分开始对客户上个月可获得的利息金额进行合资格审核，每月利息将于下月首5个工作日内发放至客户的富拓美元钱包。

4.5. FXTM reserves the right to determine or change the amount of the interest rate to issue to the clients at any point without prior notice.

富拓有权在无需提前通知的情况下在任何时间决定或修改赠予客户的利率。

4.6. FXTM shall not be liable for any margin call or losses that the client may suffer, including but not limited to losses due to stop-out level, as a reason of or during this Promotion Period.

根据本条款和条件，FXTM富拓将对客户可能由于本次活动或在本次活动期间所遭受的追加保证金或损失，包括但不限于因强制平仓造成的损失不承担责任。

4.7. FXTM has the right to withdraw qualification without prior notice if:

若出现下列情况，FXTM富拓有权撤销获奖资格，无需提前通知：

a) a breach of these Terms occurs;

b) FXTM has reasonable grounds to believe a misuse of the Promotion;

FXTM富拓有合理的理由相信活动被滥用；

c) The Client acts in bad faith and/or abusively and/or fraudulently and/or in a manner that is not in line with this Promotion and applicable Terms.

客户不诚实和/或滥用和/或欺诈和/或以不符合本促销和适用条款的方式行事。

4.8. During the Promotion Period the client can participate in any other applicable and unexpired promotions announced by FXTM. Please note that if a client participated in more than one promotion, then FXTM will review the client's trading volume (lots) fulfillment in the chronological order of the client's participation order. The same trading volume (lots) can only be counted as eligible trading volume for once. Clients are required to complete the corresponding trading volume requirements for each promotion in the order in which they successfully registered and participated.

在活动期内，客户可以参加FXTM富拓举办的其他适用的、未过期的优惠活动。请注意，客户若同时参与多个活动，在审核客户的交易量是否满足某一活动要求时，将按照客户参与活动的时间顺序进行审核。即同一交易量只可被计入一次活动资格审查，不可重复计数，客户需按照成功报名参与活动的顺序，依次完成每个活动相应的交易手数要求。

5. MISCELLANEOUS

其他事项

5.1 FXTM reserves the right, as it in its sole discretion deems fit, to alter, amend, suspend, cancel, or terminate the Promotion. In the event of modifying the Terms, FXTM shall give such notice to the client as may be required by applicable legislation. Under no circumstances shall FXTM be liable for any consequences of any alteration, amendment, suspension, cancelation, or termination of the Promotion.

FXTM富拓保留在自由裁量认为适当的情况下变更、修正、中止、取消或终止本次活动的权利，富拓应根据适用法律的要求向客户发出通知。在任何情况下，富拓不对由于活动的更改、修正、中止、取消或终止造成的任何结果负有责任。

- 5.2 Any indication or suspicion of fraud, manipulation, cash-back or bonus or swap arbitrage, or other forms of deceitful or fraudulent activity in a client's Account or multiple account with FXTM or otherwise related or connected to the interest shall nullify all transactions carried and/or profits or losses garnered therein.

若有任何迹象或FXTM富拓怀疑客户账户或多个账户或其他与赠金相关的账户中存在欺诈、操控、返现或奖金或互换套利或其他形式的欺骗或欺诈活动，所有已执行的交易和/或由此产生的利润或亏损均无效。

- 5.3 FXTM reserves the right, at its sole discretion, to disqualify any client that FXTM suspects misuses or attempts to misuse the Interest or breaches the present Terms and/or any of FXTM's operative agreements and to cancel all orders and annul all profits of such client. If FXTM, in its sole discretion, suspects any Interest or interest arbitrage or any misuse or attempts to misuse the Interest, and the client has open positions, FXTM reserves the right to withdraw the Interest. In these circumstances, FXTM shall not be liable for any consequences of the Interest cancelation.

FXTM富拓保留，在其自由裁量情况下，取消滥用或试图滥用本利息活动、违反本条款和/或FXTM富拓任何有效协议的客户参加活动的权利，取消此类客户所有定单和所有利润。如果FXTM富拓怀疑客户有任何赠金套利或任何滥用或试图滥用赠金活动的行为且客户已建仓，FXTM富拓保留撤回赠金的权利。在这些情况下，FXTM富拓不负责由于赠金取消造成的任何后果。

- 5.4 Notwithstanding the Chinese language of this document, the English wording shall be the binding version in the event of any discrepancy between the two languages.
